

Turkish Personal Data Protection Law



1. General Information

Turkish Personal Data Protection Law No. 6698 enacted on March 24, 2016 and published in the Official Gazette dated April 7, 2016 No. 29677.

According to Article 32 titled "Effectiveness" of Turkish Personal Data Protection Law No. 6698, this Laws 8th, 9th, 11th, 13th, 14th, 15th, 16th, 17th, 18th articles shall enter into force after six months following the date of publication as of October 7, 2016.

Turkish Personal Data Protection Law No. 6698 is arranged to protect fundamental rights and freedoms of the persons notably right of privacy in the processing of personal data and to arrange the obligations of the natural and legal persons processing the personal data and procedures and principles to be observed.

2. Data Controllers Inform

We, **Meteksan Savunma Sanayii A.Ş.** will use your personal data in the capacity of Data Controller in accordance with the relevant legislation and referring to Turkish Personal Data Protection Law No. 6698.

3. How will your Personal Data be processed?

According to Turkish Personal Data Protection Law No. 6698, we, Data Controller for **Meteksan Savunma Sanayii A.Ş.** can perform all kinds of transactions as like obtain from non-automatic methods, record, storage, keep, change, re-arrange, reveal, transfer, take over, making acquirable, classification or blocking of usage on condition that shared personal data is a part of any registration system wholly or partially.

4. What is the processing purpose and legal basis of your personal data?

We will process your shared personal data for the purposes of perform the supplied services pursuant to legislation, contract and technology requirements, develop the offered product and service, to be able to fulfill our obligations for information storage, reporting and information envisaged by judicial and administrative authorities, advertising and promotional activities, and analyses of our customer portfolio in accordance with the Turkish Personal Data Protection Law No. 6698 and relevant legislation.

5. Information on the people or organizations that your Personal Data may be transferred

For the above-mentioned purposes and in accordance with the Turkish Personal Data Protection Law No. 6698 and relevant legislation; the persons / organizations, which we may share your personal data are: all official authorities and institutions, our affiliated Bilkent Holding A.Ş. all the companies which Bilkent Holding A.Ş has shares or a partner of it directly or indirectly, affiliated companies, the companies which we have shares as **Meteksan Savunma Sanayii A.Ş.** principal shareholder and our company's direct or indirect domestic / foreign subsidiaries as Bilkent Holding and our company

affiliates; our other partnerships within the scope of ordinary partnerships, our service provided other shareholders, co-program partners, domestic / foreign institutions, and other third parties who supplies service to make activity and collaborated.

6. How is your Personal Data collected?

Your personal data can be collected by verbal method, written method or electronically via our website, front office, selling and marketing department officers, forms filled out in the customer visits, digital marketing, Contracts, applications, your audio and video record, forms, offers, cookies used to identify you at website look up etc.

7. What are your rights according to Turkish Personal Data Protection Law No. 6698?

- a. Whether your Personal Data is processed or not;
- b. If your Personal Data is processed, request information for this matter;
- c. To learn the purpose of processing Personal Data and whether it is used suitably for its purpose;
- d. To learn the third parties to which personal data are transferred in Turkey or abroad;
- e. To request for correction of the Personal Data, in case of the Personal Data is processed missing or fault;
- f. To request that personal data be deleted or destroyed in accordance with the provisions of Article 7 of the Law.
- g. To request that the transactions made pursuant to subparagraphs (d) and (e) above be notified to the third parties which Personal Data transferred;
- h. To object to the appearance of a result against the person himself, by analyzing the processed data exclusively through automated systems;
- i. To demand the loss indemnisation in case of suffered a loss due to illegal processing of the Personal Data.
